SPECIAL TESTING ARRANGEMENTS	If you have a disability and need special testing arrangements, mark "yes" for question #2 on the Examination/Employment Application (STD. 678).
APPLICATION	All candidates will be required to complete an Examination/Employment Application (STD. 678), Work Location Form, and Fire Fighter I Questionnaire, and must submit any other requested documents. These documents are designed to elicit a range of specific information regarding each candidate's knowledge, abilities, and potential to effectively perform the duties relative to the classification.
INTERVIEWS	Oral interviews may be scheduled as conditions warrant.
THE POSITION	A Fire Fighter I participates in wildland, rural, and structural fire suppression. As a member of a fire crew, a Fire Fighter I fights fires, repairs equipment, assists with general station housekeeping, and responds to emergency situations.
