Public Notice
Seasonal Listing of Open and Closed Roads and Campgrounds
Dry Season, 2012

As of Friday May 25, 2012 the following road and campground closures within Jackson Demonstration State Forest will be in effect. The road closures prohibit the use of all unauthorized motorized vehicles, including motorcycles and ATVs. Roads may still be used for hiking, bicycling, and horseback riding except where closed to any public access for safety concerns in certain areas. Day-use at closed campgrounds is allowed, but vehicle access and overnight camping are prohibited. **Note: Only vehicles properly licensed for highway use may be operated within Jackson Demonstration State Forest. Off-road motorcycles and ATVs are not allowed.**

Please do not drive on roads that are wet and have soft surfaces, even if they are not formally closed. Road and stream damage can occur from rutting and erosion. It is not safe to drive on roads with slippery surfaces. It is always unlawful to operate unlicensed vehicles (including off-road vehicles with or without green stickers) on State Forest roads. Off-road travel with motorized vehicles is not permitted. Please help us protect your forest resources. **Please use appropriate caution at all times.**

The following roads will generally be OPEN during the dry season of 2012:

100, 130, 200, 230, 240, 250, 300 west of 350, 300 east of 350 to 332*, 330* between 332 and 1000, 332*, 334, 350, 360* south of Road 361, 400, 410, 420, 440, 460, 462, 463, 464, 500, 700, 720, 800, 810, 830, 900, 920, 930, 940, 1000 east of 1070 (within Jackson Demonstration State Forest), 1070.

* Check with Forest staff for updated status (Some roads may be temporarily closed due to hazardous conditions, timber operations, or to protect natural resources.)

* These roads may be opened for permitted firewood cutting after logging operations.

The following campsites will be open:

All JDSF campgrounds are open except campsites on Road 361.

Note: Roads or campsites may be temporarily opened or closed at any time for maintenance or repairs, for public health and safety reasons, timber operations, or to protect natural resources.
