In compliance with the California Environmental Quality Act (Public Resources Code § 21000 *et seq.*) and Department procedures, notification is hereby given to responsible and trustee agencies, interest groups and the general public, that the California Department of Forestry and Fire Protection proposes to adopt a Mitigated Negative Declaration for the project described below.

Project Location: Legal Description: portions of T27S, R8E, Section 15, & Rancho Santa Rosa (Estrada) MDBM. APNs: 013-111-005 and 013-111-004 (Cambria area, San Luis Obispo County).

Project Description: Fuel Reduction – Create a shaded fuel break by reducing understory fuels through mechanical shredding and hand crew work on approximately 50 acres of land in the Cambria area of San Luis Obispo County.
