**PROSPECTIVE TIMBER PURCHASER:**

The California Department of Forestry and Fire Protection's Jackson Demonstration State Forest will be offering the following timber sale: West Chamberlain 2013 Sale (291 acres), approximately 2,814 MBF (net) on April 9, 2013. The West Chamberlain 2013 Timber Sale is located in Sections 19 and 30, Township 18 North, Range 15 West, and Section 25, Township 18 North, Range 16 West, MDB&M.

Please note that the Timber Sale Agreement is in draft form as CAL FIRE is reviewing it and the existing language may be modified.

*West Chamberlain 2013*

The minimum bid rate per thousand board feet for redwood is \$325. The price has been fixed at \$20.00 per thousand board feet for Douglas-fir and \$20.00 per thousand board feet for all other whitewoods (grand fir/western hemlock). Timber volume within the sale area has been estimated by a combination of variable radius plots and 100% tree tally cruise of the sale area. Sale acreage has been determined from the map and all trees selected for harvest in the commercial thin, selection, and WLPZ areas have been marked with pink-glo paint.


