



CAL FIRE Firefighter Training

CAL FIRE personnel answer the call more than 300,000 times for emergency incidents each year. It is the goal of the Department that every fire engine responding from a CAL FIRE station carries CAL FIRE firefighters, fire apparatus engineers and/or fire captains that have met, at a minimum, the extensive training requirements included on this sheet.

Firefighter I

- CAL FIRE Firefighter I Basic Training
 - Personal Protective Equipment
 - Self Contained Breathing Apparatus
- Wildland Firefighter Safety & Survival
- First Responder Medical Training
 - Public Safety CPR/AED
 - Communicable Disease Awareness
 - Child & Elderly Abuse
 - Sudden Infant Death Syndrome (SIDS)
- First Responder Operational Hazardous Materials Training
- EEO/Sexual Harassment
- Introduction to ICS – I-100
- Job Enhancement
 - Firefighter I Advanced (100 hour) Training
 - 160 total hours required within the first year



Firefighter II

All Firefighter I Requirements *and*:

- Basic Fire Control – Firefighter Academy
 - Live Fire Training
 - Rope Rescue & Confined Space Rescue
 - EEO/Substance Abuse Prevention
- Basic ICS – I-200
- FFII Joint Apprenticeship Committee (JAC) Syllabi
 - 466 total hours required within the First Year syllabus
 - 144 hours for both the Second and Third Year syllabi

Fire Apparatus Engineer

All Firefighter I & II Requirements *and:*

- Basic Fire Control – Company Officer Academy
 - Driving & Pumping Operations
 - Preliminary Fire Investigations
 - Wildland Strategy & Tactics
 - Incident Management I
 - Intermediate Fire Behavior – S-290
- FAE Joint Apprenticeship Committee (JAC) Syllabi
 - Intermediate ICS – I-300
 - Incident Management II
 - 740 total hours required within the First Year syllabus
 - 144 hours for both the Second and Third Year syllabi



Fire Captain (A)

All Firefighter I, II and FAE Requirements, *and:*

- Continuing Education in all areas of Firefighting & EMS/ EMT
 - Annual refresher training on pumping & firefighting skills
 - Substance Abuse / Communicable Disease Prevention
- Leadership Development
- Job Enhancement
 - Incident Management III



Fire Captain (B) Crew Captain

(Fire Crew Captains supervise inmate, ward, and fire crews)

All Firefighter I, II and FAE Requirements, *and:*

- Continuing Education in all areas of Firefighting & EMS/EMT
 - Annual refresher training on pumping & firefighting skills
 - Substance Abuse / Communicable Disease Prevention
- Fire Crew Captain Administration & Operation Training
 - 80 hours additional training in two modules
- Job Enhancement
 - Incident Management III
