## **PROJECT DESCRIPTION**

CAL FIRE currently leases property from a landowner on Call Mountain that has been improved with telecommunication facilities. The lease is set to expire, and it has been determined that a land transfer would be preferred to continue optimal communication requirements. The project proposes to transfer property owned by CAL FIRE (APN 027-170-011 and a portion of APN 027-170-010) to an adjacent landowner in exchange for the leased property that is of similar value (Portion of APN 027-170-010). The CAL FIRE property consists of 1.3± acres, is zoned Agricultural Rangeland (AR), and is improved with a cistern and dilapidated lookout tower. The adjacent leased property consists of 1.0± acres, is improved with telecommunication facilities, and is also zoned AR. No improvements are proposed as a part of this property exchange.
